



...Professional advisers, lawyers, accountants, and trustees, who are involved in **estate planning**, **tax planning**, **estate freezes** and the like are fully aware of their obligations to act honestly and fairly and avoid conflicts of duty and loyalty...  
...It is very clear that on one side of the line, there is nothing wrong, improper or illegal, in **planning** and executing a transfer or transfers of assets in **estate planning**, **tax planning** or in creditor-proofing if the client is solvent...  
...Accountants regularly advise on tax savings, **tax plans**, **estate plans** and prepare the client's financial statements relying exclusively on the client's information and documents...  
... whether the purpose is an **estate plan** for succession to family members...

3. **Entitlement to RRSP Funds in Bankruptcy: CIBC v. Whaling**

...The Court went on to hold that nothing in Section 146(2)(c.3) forbids a beneficiary of an RRSP **plan** from using RRSP property as security if the beneficiary chooses to do so, but rather dictates that the **plan** ceases to be a registered retirement savings **plan** under the ITA with the beneficiary losing the tax benefits associated with a registered **plan**...  
...Pursuant to Subsections 146(12) and (13) of the ITA, an amended **plan** shall be deemed for the purposes of the ITA not to be a registered retirement savings **plan** where, on any day after the **plan** has been accepted by the Minister for registration, the **plan** is revised or amended in such a way that it does not comply with the requirements for registration pursuant to Section 146 of the ITA...  
...In such event, the foregoing provisions of the ITA specifies that the tax payer who was the annuitant under the **plan** before it became an amended **plan** shall include the income from the **plan** in that tax payer's income for the taxation year...  
...While such result may create a windfall for financial institutions in Ontario, it would cause havoc in both personal **estate planning** for residents of Ontario and the taxation system in Canada...

4. **U.S. Bankruptcy Priorities for the Foreign Investor or Welcome to America! Now Where Do You Stand?**

...20 Obligations incurred pursuant to an executory contract which has been entered into or assumed by the trustee or debtor in possession under s. 365 and administrative rent for the reasonable value of the use and occupancy of real **estate** or the utilization of personal property by the **estate** are administrative expenses...  
...In circumstances where a foreign investment is made through a branch, division, subsidiary or affiliate of the foreign investor and a bankruptcy proceeding has been
